The Ngarrindjeri (literal translation- the people who belong to this land) are an Australian Aboriginal nation, language group or confederation of 18 lakinyeri (clans or tribes), and 77 family groups, who speak related dialects of the Ngarrindjeri language.

They are the traditional Aboriginal people of the lower Murray River, western Fleurieu Peninsula, and the Coorong of southern, central Australia.

# RECONCILIATION BOARD OF MANAGEMENT CHAIRPERSONS' MESSAGE


It gives us great pride to present the Tailem Bend Community Centre Charter 2019-2022.

Our plan is based on three core ingredients – respect, relationships and opportunities.

We are confident that together we can make an important contribution with respect to reconciliation and look forward to continuing our journey.





# **OUR VISION FOR RECONCILIATION**

#### **Vision Statement:**

The Tailem Bend Community Centre Incorporated (TBCC) will be a self-sustaining enterprise that supports the diverse needs of the community. 'TBCC values its culturally diverse community and is committed to extending the process of Aboriginal reconciliation in partnership with Aboriginal and Torres Strait Islander Peoples.'

# The Six Guiding Principles

#### 1 Participation

TBCC will seek the advice and participation of Aboriginal and Torres Strait Islander Peoples on key issues of interest to the community, and will promote cooperative approaches on these issues.

#### 2 Connection

TBCC will enter into consultative process to seek the views of local Ngarrindjeri People and other Aboriginal communities about reconciliation and other key issues.

#### **3 Communication and Public Awareness**

TBCC will promote its support for reconciliation to increase public awareness and understanding of the reconciliation process and, in particular, to ensure that the mainstream community is aware of the culture and aspirations of Aboriginal organisations such as Moorundi, Tumake Yandi and Raukkan Community Council Peoples.

# 4 Our Community activities

TBCC is committed to providing relevant community activities and assistance to Ngarrindjeri People to actively support their positive engagement in our community.

#### **5 Cultural Identity and Heritage**

TBCC acknowledges the continuing cultural and spiritual obligations the Ngarrindjeri People have in their lands and seas, and will seek opportunities to recognise Ngarrindjeri heritage through physical features of TBCC and by supporting community cultural activities.

#### **6 Commemoration**

TBCC will work with the Ngarrindjeri community to celebrate important Ngarrindjeri celebrations and events linked to significant sites in the Coorong region.

Established in 1987, the Tailem Bend Community Centre (TBCC) is an independent organisation that supports the diverse needs of Tailem Bend and the surrounding community.

The TBCC provides vital community services that are affordable, accessible and targeted to those most in need, with a strong focus on encouraging social interaction and lifelong learning. Services are diverse and include the hire/use of facilities including a modern function room and commercial kitchen, administrative services and the delivery of a wide range of programs for various ages and groups.

The key objectives of the TBCC are:

- 1. Advance community connections, individual health wellbeing and independence.
- 2. Reduce isolation, encourage and support social inclusion, volunteering, and training.
- 3. Increase the community's access to information, services, and support transport options.
- 4. Expand programs, secure grant funding and social enterprise opportunities.
- 5. Develop facilities, environmental resilience and cultural diversity.
- 6. Maintain Service Excellence and Audit frameworks and continuously improve.

### **OUR COMMUNITY**

A diverse range of primary production industries operate within the district, including cropping, livestock (sheep, cattle, pigs, poultry), dairying, commercial fishing, horticulture and mining. The Coorong has struggled with drought through the years which causes hardship in some communities. Much of the District is serviced by major freight routes, including the Dukes, Mallee and Princes Highways as well as the Adelaide to Melbourne rail line.

There is a relatively high incidence of socio-economic disadvantage in the community with the CDC ranked in the top 20% of disadvantaged communities in Australia. Within our region we have a significant population of Ngarrindjeri people and other Aboriginal and Torres Strait Islander community making up 6% of the population.



# **OUR CHARTER**

TBCC adopted its Charter in 2018 and it is our guiding document for connection and engagement with the Ngarrindjeri people and other Aboriginal and Torres Strait Islander over the next three years.

TBCC has had a long standing, positive working relationship with the Ngarrindjeri community as the Traditional Owners and Custodians of the Coorong and this is significantly important to us at TBCC.

TBCC networks have Aboriginal organisations such as Moorundi Aboriginal Community Controlled Health Service Inc (Moorundi ACCHS Inc), Tumake Yandi and Raukkan Community Council and where appropriate work together to build on the wonderful initiatives with positive outcomes that educate and raise awareness of services for Aboriginal people in the Coorong.

The TBCC's Charter is our commitment to reconciliation.

### **GOVERNANCE**

The TBCC is an Incorporated Body, managed by a dedicated volunteer Board of Management Committee, with the assistance of a dedicated group of volunteer staff. A paid CEO is employed five (5) days per week to undertake administrative duties.

The TBCC is supported by a number of strategic partners, including Community Centres SA (CCSA), the peak body for community centres in South Australia, and the Coorong District Council, which acts as an auspicing body for Commonwealth Home Support Program (CHSP) funding, in addition to providing in-kind support and a peppercorn lease of the TBCC premises.

The financial and structural management of the TBCC is widely recognised by community centres throughout South Australia as an excellent model, and the Coordinator is regularly asked to facilitate sessions with the Committees of other centres on how to develop best practice management and financial models.
